The programme has been shortened to one item in order that members may have an informal meeting to discuss the following urgent and important matter:

The possibility of obtaining permanent accommodation and normal club facilities at the premises of the University of London Club, 21, Gower Street, W.C.1, has recently arisen, and the Committee consider that this chance to re-establish the Club on a full basis is not likely to recur.

**To the Old Members**—The arrangement with the University of London Club would almost certainly involve sinking the sum of £500 (of your accumulated funds) in the venture. If the Trustees do not hear from you by 22nd July next, they will assume that the proposal has your approval.

**To the New Members**—The number of subscriptions still owing by new members is considerable and the Committee will be quite unable to proceed any further with negotiations without being assured that members who joined in 1951 will not only pay the 10/6 subscription due for 1952, but will also make it up to the full rate of subscription, two guineas, when called upon. A form of reply to the Hon. Treasurer is enclosed for signature.
